

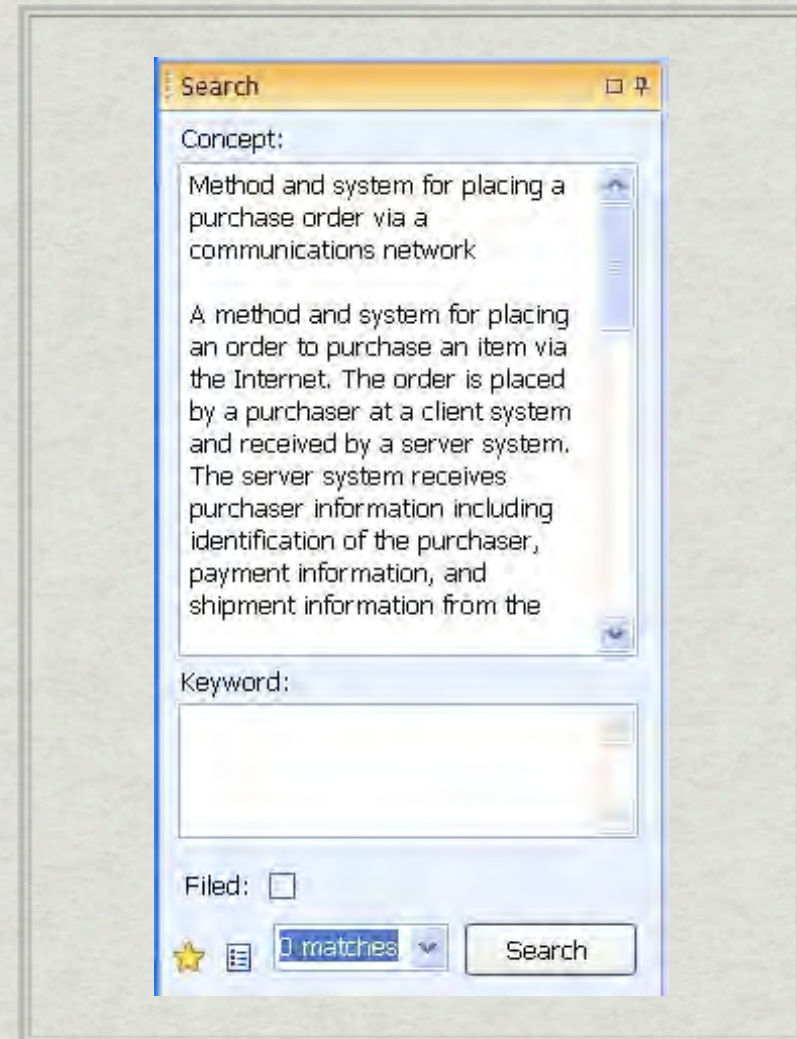

- * No need to distill complex ideas into keywords or Boolean strings



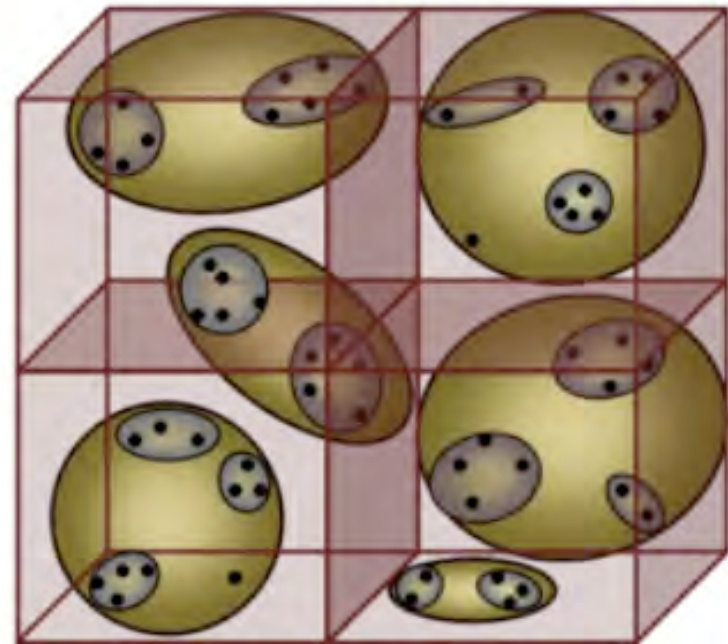
Searching With Coronado IP

Searching With Coronado IP

- * Search uses Latent Semantic Analysis to find semantically related documents
- * A multi dimensional concept space learns the “language” of inventions and patents



Searching With Coronado IP

- * The score indicates the “closeness” between the search source and the concept index
- * Low scores can mean novelty of the search source
- * High scores indicate closeness to the search source

VEHICLE ADAPTED TO LAND AND AIR TRAVEL

Abstract

A vehicle adapted for land and air travel comprising, a fuselage having a longitudinal duct therein, means within said longitudinal duct for creating an airstream therethrough, a vertical duct extending about said first duct and fan means mounted within the vertical duct having actuating means located within said longitudinal duct and operable by said air stream therein for causing a flow of air from the upper surface of said fuselage through said vertical duct to be expelled from an exit in the lower surface of the fuselage.

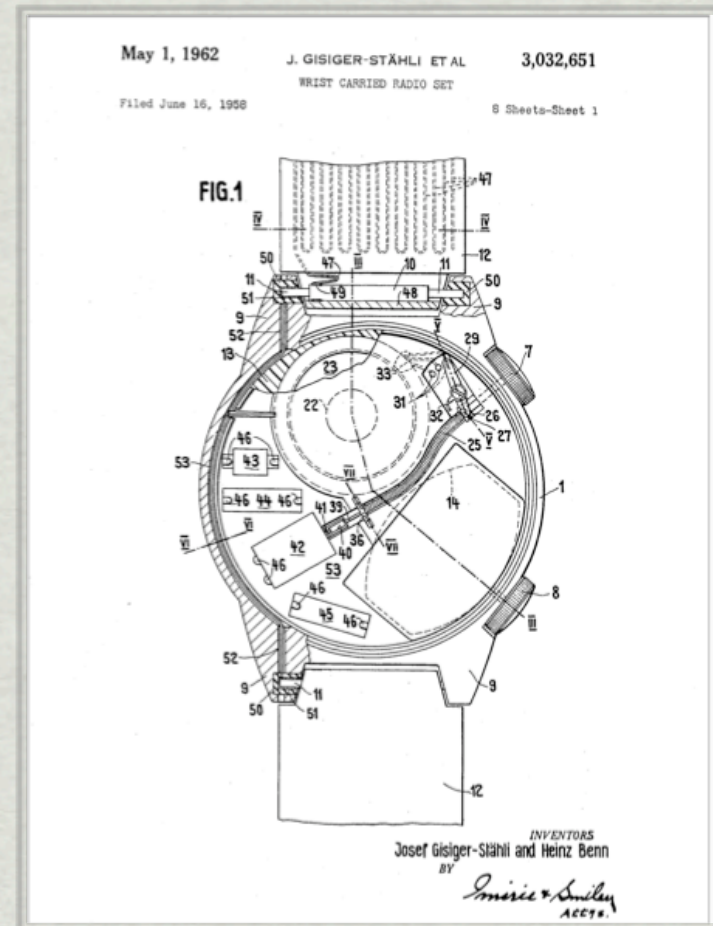

The "One Click" Patent Search Form

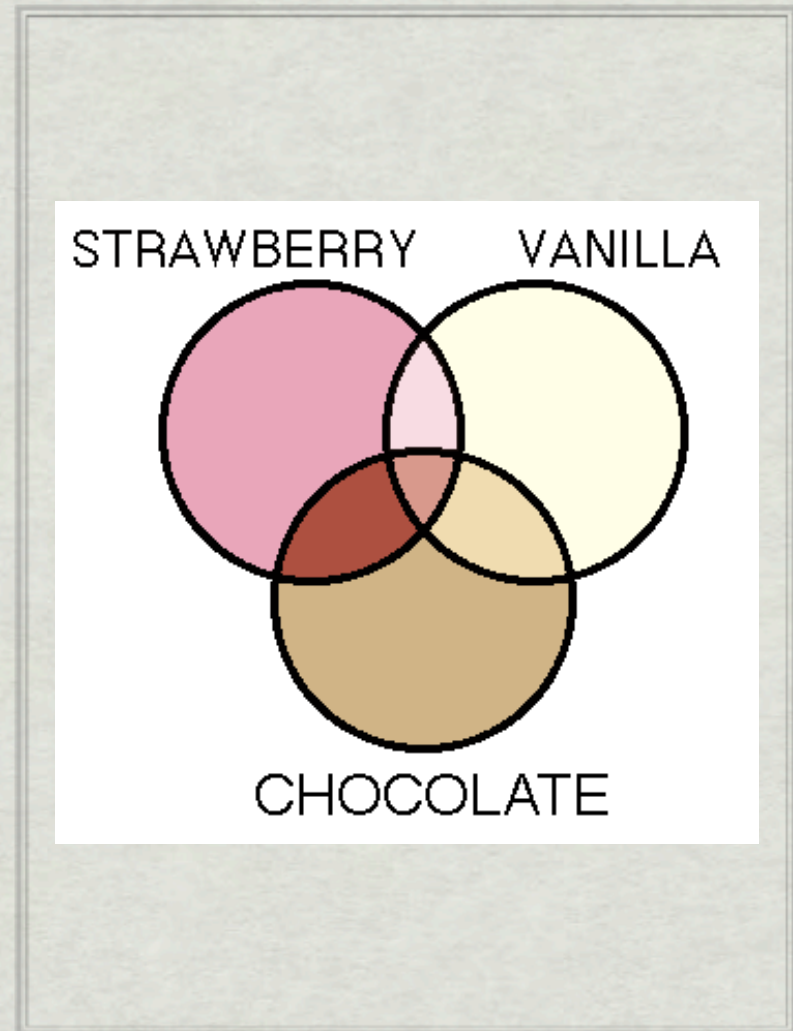
Keywords Don't Work

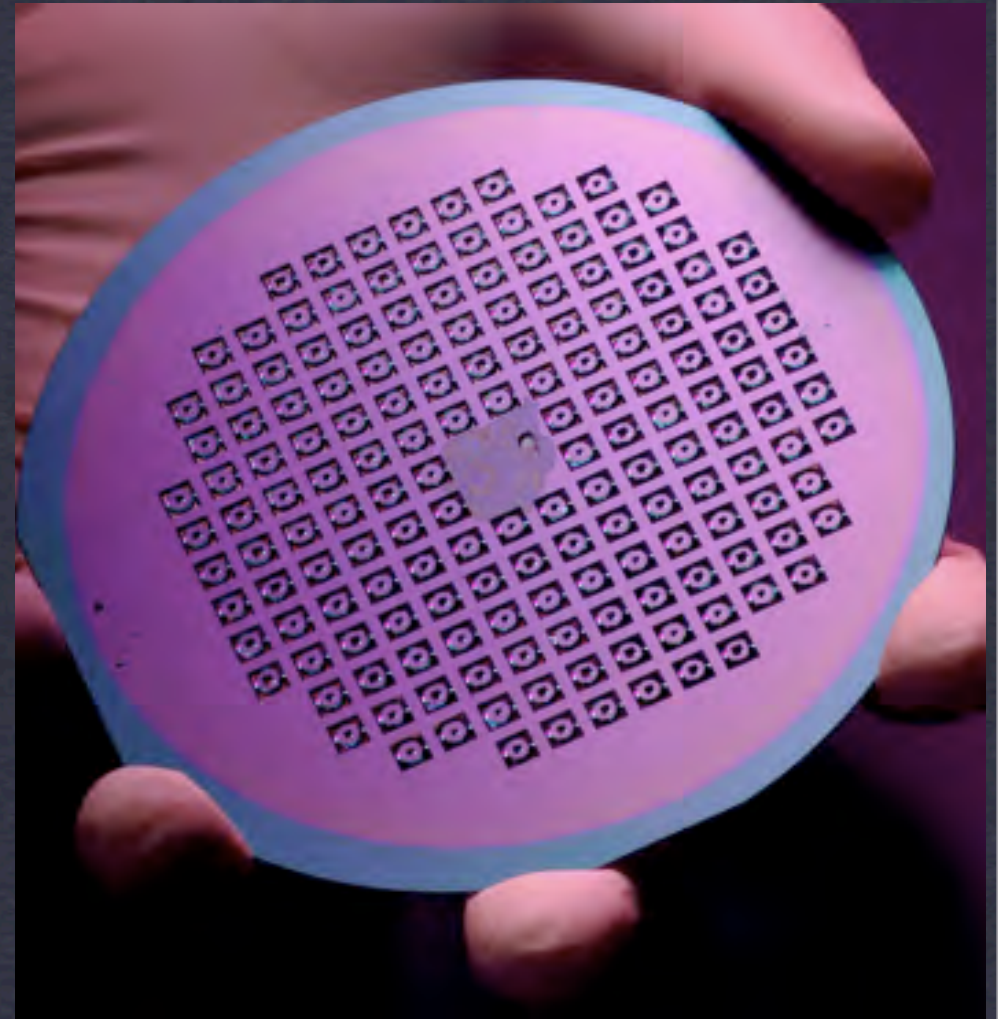
- ✳ Complex ideas can't be distilled into keywords
- ✳ 50% of all searches use two or three words
- ✳ Google only supports 10 Words



Booleans Don't Work

- * Complex ideas can't be distilled into keywords with and, or, and not between them
- * Creating Boolean searches that work is time consuming and hard



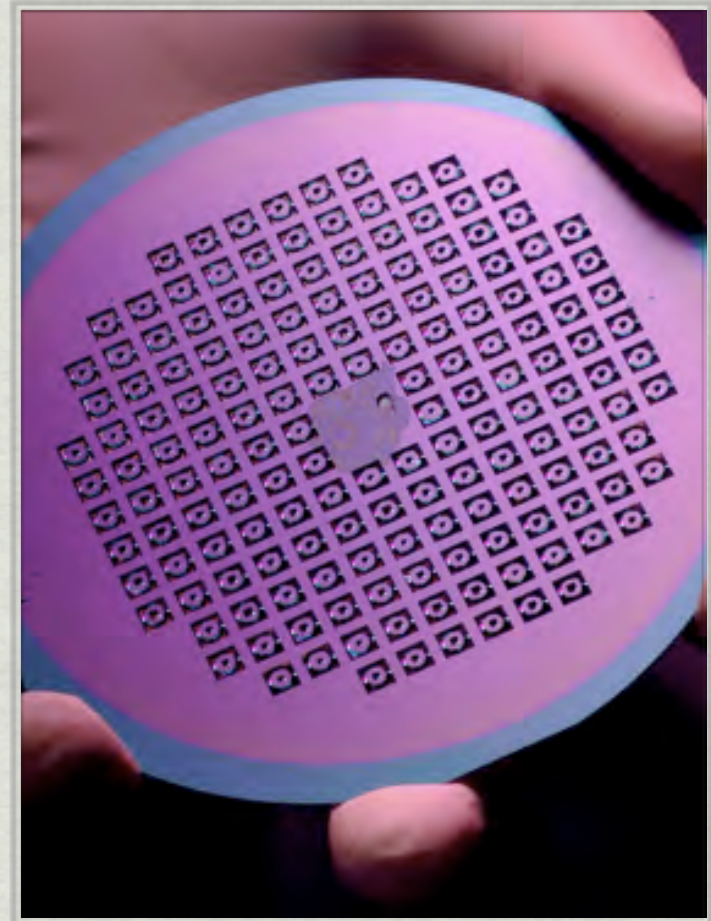
